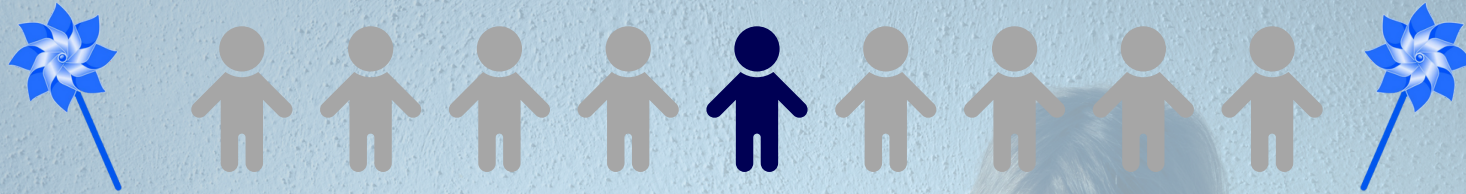

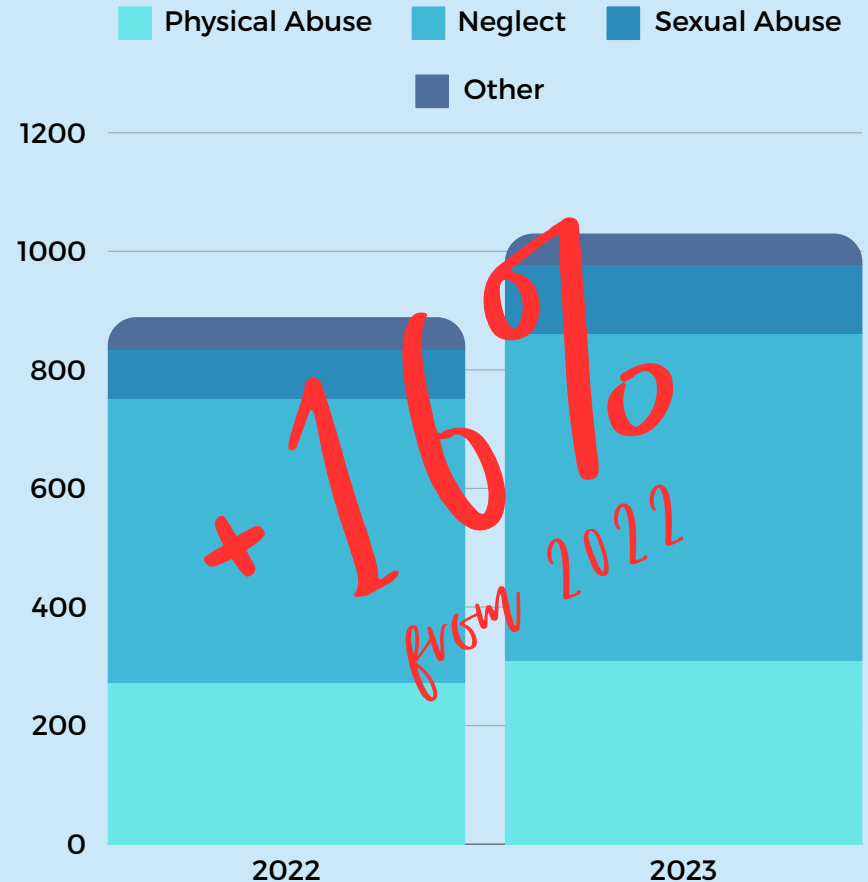
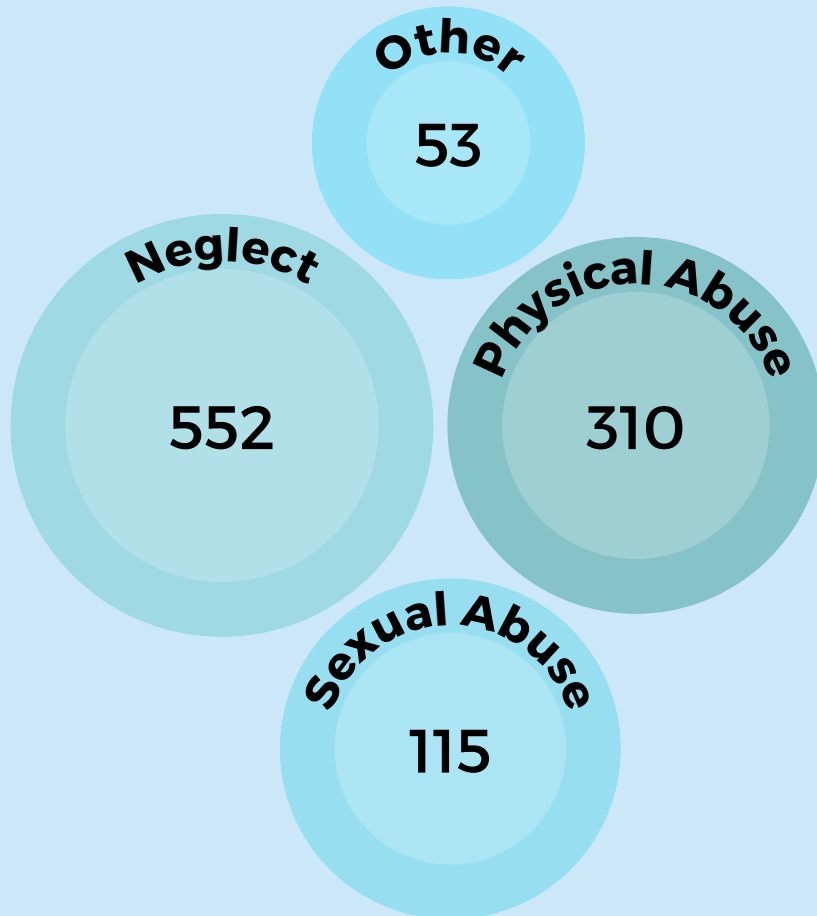

**TOP REFERRAL
SOURCES - 2023**

The safety of children is our first concern. If you suspect a child is being abused or neglected, you should call us at 740-389-SAFE weekdays between 8:30 am and 4:30 pm. For emergencies, after hours or on weekends or holidays, call the Marion County Sheriff's Office at 740-382-8244 and ask to speak with the on-call Child Protection Caseworker.

SAFETY INVESTIGATIONS - 1,030 TOTAL

We complete investigations on all reports that meet Ohio's legal definition of child maltreatment. These services are provided **24 hours a day, 365 days a year.**



During safety investigations, information is gathered to determine what resources the family may be lacking and if there is currently risk to the child's safety, health and welfare. This process emphasizes the working partnership between families, child protection, and community agencies to promote child safety, well-being, and permanency.

Child Abuse & Neglect Training is offered throughout the year at Marion County Children Services. This training is intended to increase knowledge about child abuse and neglect, and the reports and assessment process. 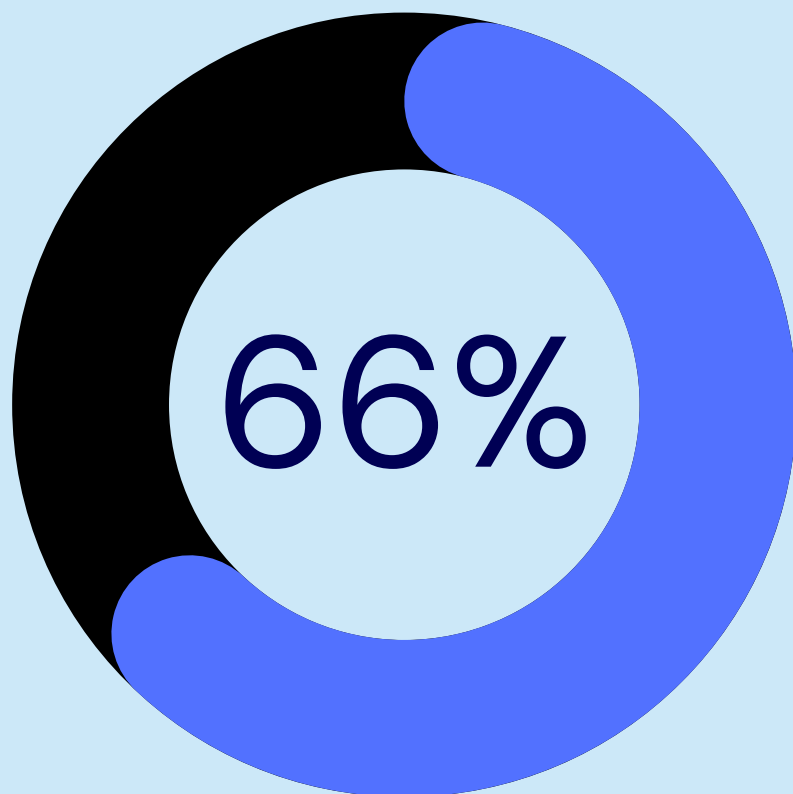

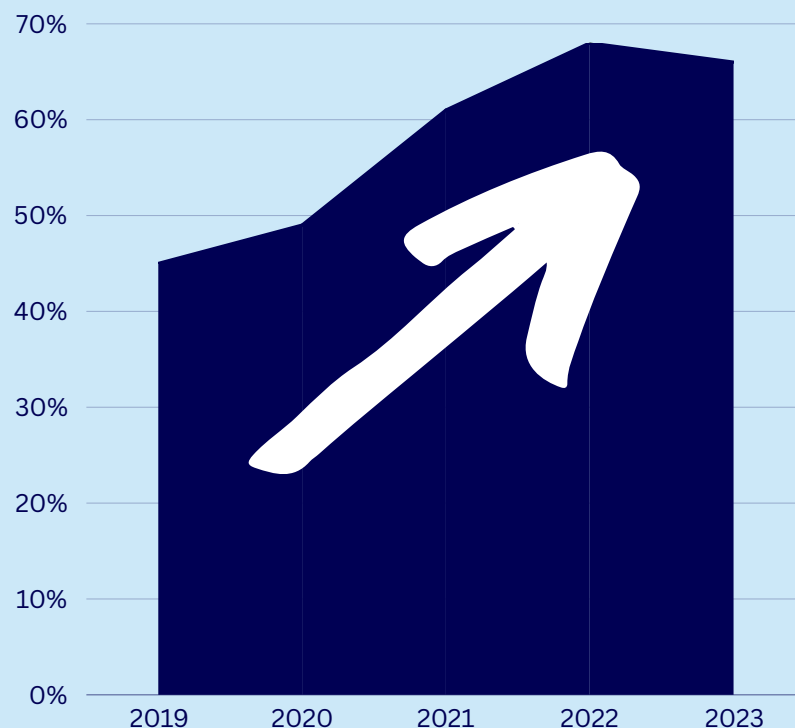

HOME BASED SERVICES

When our continued assistance is needed, supportive services are provided to promote the safety of children within the home whenever possible. The caseworker and the family work jointly to create and set goals to strengthen the family and reduce risk to the children.

FOSTER CARE & KINSHIP SERVICES



When children are at serious risk of harm, removal from their home environment is necessary. We make every effort to place children in the least restrictive, most family-like setting while working with families to improve situations and promote successful reunification. Children placed with extended family or friends are less likely to suffer from stress that results from being removed from their family.

KINSHIP SUPPORT SERVICES

Children placed with kinship have reduced trauma, and are typically able to stay in their community, connected to their schools and other providers.

The KCP Program provides family stabilization and caregiving services for kinship caregivers when the caregivers have accepted temporary custody of a child.

Stabilization funding can help pay for incidental costs incurred when beginning to care for a child unexpectedly.

Caregiving funding can be provided as a reimbursement for child caring services.

**KINSHIP
CAREGIVER
PROGRAM**

KSP is a state program that provides financial payments to eligible kinship caregivers for the placement of children in their homes when a child is in Agency custody for up to six months.

A kinship caregiver who is not certified as a foster caregiver is eligible to receive KSP funding for a child(ren) placed in the kinship caregiver's home when the child(ren) have an open case with the agency and for whom a kinship assessment is completed.

**KINSHIP
SUPPORT
PROGRAM**

KGAP is a program available to eligible kinship caregivers who become legal custodians or guardians of the children placed in their home. The kinship caregivers must become licensed by the State of Ohio to care for the children they have placed in their home in order to receive the funding.

The kinship caregiver must have committed to caring for the child on a permanent basis.

**KINSHIP GUARDIAN
ASSISTANCE
PROGRAM**

The KPI program was created to support children in the homes of family or friends who have committed to caring for them when birth parents cannot. KPI provides time-limited incentive payments to families caring for their kin.

Applicants of the program who are eligible kinship caregivers that hold legal custody can receive a payment every six months for a total of up to eight payments to support the stability of the child's placement in the home.

ADOPTION SERVICES

Children who are unable to return to family deserve a safe and permanent home. Nine children found their forever families through adoption.

Post-adoption special services subsidy are available for qualifying families to help ensure their ability to meet the special needs of their children after adoption. 98 children (57 families) received post-adoption services.

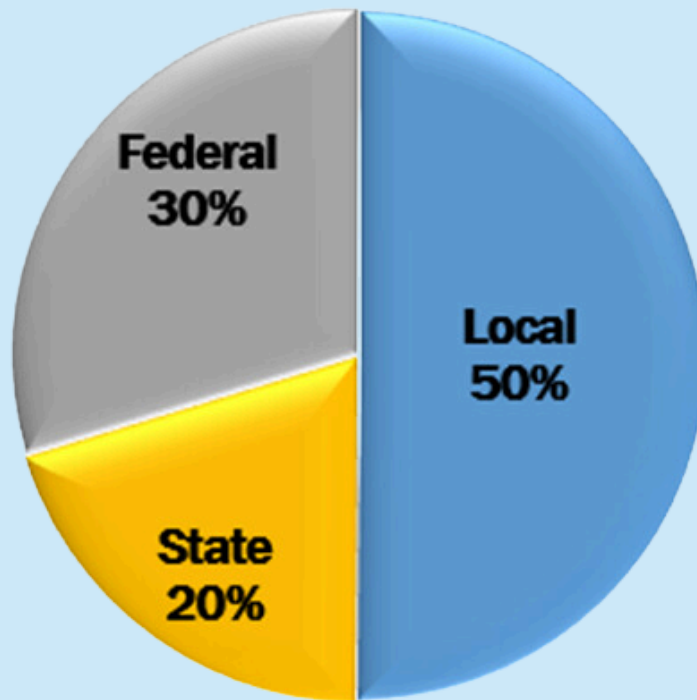

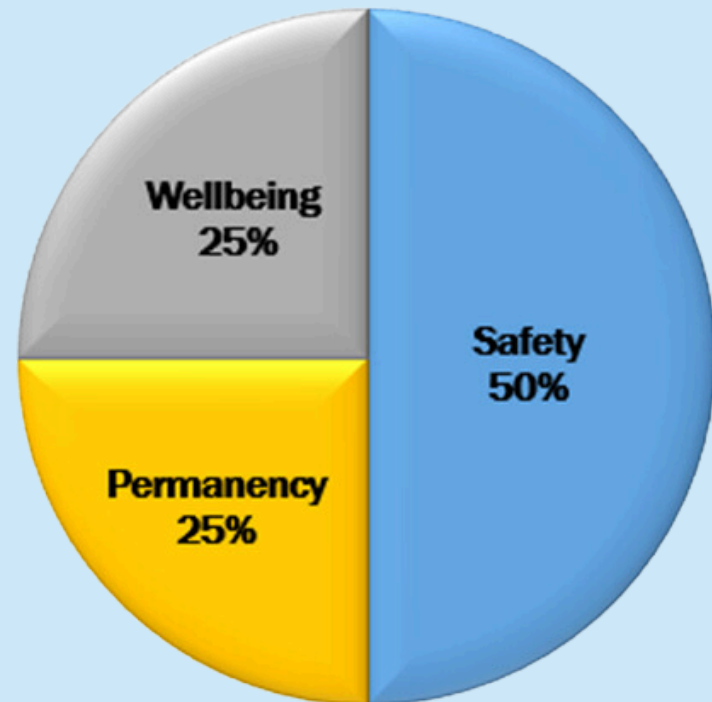


Our primary funding source is a 10-year property tax levy. The levy generated \$3,378,134.86 in 2023.

MOST IMPROVED



The Office of Families and Children recently established a Best Practice Incentive Program. This program provided funding to agencies who increased or maintained benchmarks in certain areas of child protection. Advancements in these areas are critical to our state's success in making transformative change for families served by our child protection system.

Marion County was in the top three most improved medium-sized counties in Ohio!

The Agency has received a total of over \$18,981 in incentive funds in 2023 as a result.

Marion Community,

As I reflect upon 2023, I am reminded of the Frederick Douglass quote, “It is easier to build strong children than to repair broken men.” Ohio’s youth are experiencing profound emotional, mental, and behavioral health needs. The unfortunate reality is that we are facing a foster care and treatment crisis across the State, resulting in challenges finding appropriate and available placement and treatment options for families.

One out of every nine children in Marion County received supportive services from our Agency in 2023. Last year, 1,030 assessments of child safety were completed. Research indicates the stability and connectedness kinship placements provide leads to better outcomes for children. There were 252 Marion County children unable to remain safely in their homes and kinship placements were successfully secured for 60% of those children.



In Marion County, our available foster homes decreased by 24%. While we continue to work with our local and state stakeholders to advocate for service availability to support our children and families, we need loving and patient homes within our community willing to open their hearts to children in need.

The child protection workforce is an essential piece to achieving safe children and strong families. We applied for and were awarded \$43,200.32 through the Ohio Department of Job and Family Services (ODJFS) Workforce and Retention Grant and successfully reduced our casework turnover rate by 41%. Additionally, our dedicated workforce met a critical benchmark and was awarded an additional \$18,981 from ODJFS in Best Practice Incentives.

We are dedicated to the Marion community and will continue to advocate for the services needed to provide hope for families. Our 2024 focus is to increase our kinship services, maintain youth within their community by recruiting and supporting local foster families, and decrease the time children remain in foster care.
